## 9. Washington Ball Association.

Mayor Ryan Kern, a member of the Washington Ball Association, presented a list of projects and upgrades that the Ball Association would like the Council to consider at the ballfield. Improvements included to remove/replace the concession stand and restrooms; and add a storage closet, crow's nest, water system and batting cage on the west side of the ball field.

Kern stated the group is looking at grants to help pay for the project but they can't apply for grants because they don't have a design plan and cost estimates. Once they have a plan and estimate they'll bring it to the Council for approval and make a request to be considered for some funding from the Larry Davison bequest.

#### 10. Playground Committee.

Playground committee members Taylor Miller and Andrea Alldredge were present to discuss the playground project. Copies of their latest meeting minutes were given to Council for review.

Miller said after visiting with City Attorney Elizabeth Baskerville-Hiltgen upon review of the contract with Leathers and Associates the committee has concerns. They were given an estimate without seeing a design concept of the playground and if they don't meet the financial obligation, they would have to pay \$100 per hour to redesign. The committee is worried that more money will be spent on design fees rather than the playground.

The committee encouraged Council members to go down and look at the condition of Munchkinland playground and are also waiting on quotes and playground designs from other companies. Miller said Leathers & Associates was gracious enough to extend their contract another month but wanted the Council to know if they don't sign the contract and decide to go with them eventually, the cost would probably go up. The committee will get back in touch once they have the designs and cost estimates.

# 16. City Administrator Report.

- a) Employment Openings. Staff advertised help wanted ads for street/water/wastewater operator and power plant operator/superintendent in the Washington, Clay Center, Belleville and Marysville newspapers, as well as KRWA, KMEA, LKM, and KMU websites, and through KCLY radio station, in addition to the City's website and Facebook page.
- b) PFAS Testing. In order to continue with the PFAS settlements as previously approved by the Council, baseline testing will be required by December 14, 2023. Staff will work on a cost estimate, and will attend a webinar in September to learn more about the requirements. Forever chemical possible carcinogenic (fire fighting foam, plastic) which takes forever to breakdown and become non-hazardous. Chalfant stated the City should have a minimal risk due to where the water wells are located.
- c) Industrial Park Utility Extension. Everything is installed for the Industrial Park utility extensions. Staff is working with the contractor to get the water main disinfected, three different flushing and rounds of test samples sent in, but 1 of the 2 required tests within 24 hours has come back positive for coliform bacteria. Contractor will hyper chlorinate the entire main and flush again this coming week.
- **d)** Substation Transformer Repair. Repairs to the D Street substation have been put on hold until October.
- e) Sewer Lining. Sewer lining project for this year has been completed. There was one section in the 300 Block of West College Street that could not be lined as it changes from 8" to 6" pipe in the middle of the block.
- f) US 36 & Grove Street. Smoky Hill Construction poured the invert for the storm sewer inlet on Monday at the intersection of Grove Street and US-36 Highway just behind the KDOT right-of-way.

## 17. City Clerk's Report.

- a) Reports. The Washington County Senior Citizens Meal Site July 2023 financials and Fire minutes for August were given to the Council for review.
- b) KMEA/KMGA Annual Conference. The KMEA/KMGA Annual Conference is Oct. 19-20 in Wichita. Full conference registration is \$130. Power Plant Operator David L'Ecuyer has expressed interest in attending. Elected official registration is free and if interested in attending please contact the City Clerk so conference and motel registration can be made.
- c) Electric Utility Rates. City Clerk Denise Powell reminded the Council that electric utility rates will increase from .1255 to .1275 per kilowatt as of August 1, 2023, usage and the base rate will increase from \$5.20 to \$7.50 for residential customers and \$7.28 to \$10.00 for commercial customers effective August 1, 2024, per Ord. 817 which was passed July 5, 2022.

### 18. Reports.

### Carolyn Pinnick.

a) Cell Tower. Pinnick inquired and expressed concerns about the proposed cell tower location. Also inquired if City would receive income from the tower. City Administrator Chalfant stated the City would receive rent. Once the company determines if they wish to pursue placing a tower on the site, there would be a negotiation process.

### Terry Morse.

a) Storm drains/Streets. Morse inquired about cleaning storm drains, spraying weeds and cleaning the streets.

### Mary Ann Crome.

a) Code Violations. Inquired about the code violation process. Consensus of the Council was that it is time to get serious about violations. Council members will create a list of violations they would like the Staff to pursue and bring to next Council meeting.

### Jerry Fuhrken.

a) Patching Streets. City Administrator Carl Chalfant is pursuing assistance from contractors to assist with patching and sealing streets. All streets east of C Street are scheduled to be sealed in 2023.

#### **Roxanne Schottel.**

a) Work Force. Visited about the shortage of work force and unfortunately everyone is shorthanded and this is the new norm.
